New Options for Membership Dues!

For over a decade, ASTD Nebraska has maintained the same cost and options for dues. At the eve of 2012, it is time for an overhaul of the dues structure. We are so excited to announce that, beginning January 1, 2012, you will have some new options and increased value for your membership dollar. Memberships are non-refundable and non-transferable.

The new dues structure for ASTD Nebraska starting January 1, 2012 is as follows:

ASTD Nebraska Memberships

Renewal

If you were an ASTD Nebraska member in 2011, you will be able to renew at the 2011 rate of \$50 in 2012 on your renewal date.

New Member

Those who join ASTD Nebraska as a new member in 2012, the membership will be \$60.

Corporate Membership

For every four employees from the same company who join at the ASTD Nebraska New Member rate (\$60), the 5th employee from the same company is free.

Student Membership

With a valid student ID, members who are enrolled as full-time students (12 credit hours per semester) may enjoy membership at \$25 per year.

Transition Membership

Members who are currently looking for work may still network and enjoy the benefits of membership at a reduced rate during their transition for up to 12 months. The Transition Membership is available by request for \$5 a month in ASTD Nebraska membership dues and \$10 to attend a monthly Professional Development and Networking event. Once the member becomes employed or has enjoyed this membership for 12 months (whichever comes first), membership rates will return to normal.

Power of 2 Memberships

As a service to our ASTD Nebraska members, we will take care of the paperwork and offer a discount to our members who would also like to be members of ASTD at the National level.

Power of 2 Renewal

If you were an ASTD Nebraska member in 2011, you can renew with ASTD Nebraska AND ASTD National with the \$10 Nebraska renewal discount and the \$30 Power of 2 discount for \$229 total (\$179 National + \$50 Nebraska.) You need only to have been a Nebraska member in 2011 to take advantage of this tremendous discount.

Power of 2 New Member

New Members in 2012 can join with the Power of 2 discount for \$239 (\$179 National + \$60 Nebraska.)

Add-ons

We have a few enhancements available to increase the value and convenience of your membership. These can be added on to ANY of the memberships above with the exception of the Transition Membership:

Plus 3

For an additional \$60, you can enjoy the convenience of paying for three monthly employee development and networking events.

Plus 6

For an additional \$120, you can enjoy the convenience of paying for six monthly employee development and networking events.

Plus 9

For an additional \$180, you can enjoy the convenience of paying for nine monthly employee development and networking events.

2-Year Membership

Pay your membership for 2 years and enjoy a 10% discount. Discount does not apply to "Plus" or "Power of 2" options.

We know you will find great value and added ease in these new options for 2012! Please note: Memberships are non-refundable and non-transferable. None of these options affect pricing on Big Events or workshops.

Membership by the Numbers

Numbers At-A-Glance:

The ASTD Nebraska membership count on November 1, 2011 was exactly the same as on October 1. We have 307 members, with 95 also being members of the ASTD National organization. This equates to 31% dual membership.

Because we are sustaining our membership above 300 members, our Chapter will officially be considered a large ASTD organization, as of

January 1, 2012.

The size categories are:

- Small** - Chapters consisting of 100 or fewer active members on January 1.
- Medium** - Chapters consisting of 101-300 active members on January 1.
- Large** - Chapters consisting of 301 or more active members on January 1.

Chapter Excellence Awards, based on results in a given calendar year, will be presented during Chapter Leader Day at the ASTD International Conference and Exposition annually. The ASTD National organization will award a \$1,000 cash prize for each award of excellence in each of three chapter size categories, for a total of nine awards. The awards of excellence are:

Excellence in Strategic Partnership

Chapters that make a significant impact on local businesses and communities.

Excellence in the Advancement of the Workplace Learning and Performance (WLP) Profession

Chapters that significantly foster workplace learning and performance in their community and professionalizing the industry through promoting the Certified Professional in Learning and Performance (CPLP™).

Excellence in Membership Growth

Chapters that demonstrate the highest overall growth rate of joint chapter and national members.

2012 ASTD Nebraska Membership Drive:

Our chapter is planning a membership drive for 2012. Activities and periodic communications are planned throughout the year.
